

Global Accountancy Leaders Identify Key Issues For 2012

The 2011 IFAC Global Leadership Survey of the Accounting Profession identified three issues of particular concern to the profession in 2012: the difficult global financial climate, enhancing the reputation/credibility of the profession, and addressing the needs of small- and medium-sized practices and small- and medium-sized entities. Additional concerns for this year include: issues related to EU draft legislation, public sector/sovereign debt issues, increased regulation, global regulatory convergence, the role of the professional accountant in business, and auditor independence. The survey results include data from 123 respondents from 71 countries and jurisdictions who took the survey from December 1, 2011 to January 11, 2012.

...as it gets serious on Corporate Social Responsibility

The Institute's Public Relations Officer Dillon Kamutenga (DK) had a brief chat with the newly elected CASS president Arnold Chirombo (AC) to get a clearer understanding on the scheduled donation to be handed over to Mbuya Nehanda Children's home.

DK: Briefly tell about Mbuya Nehanda Children's Home and why you chose it

AC: Mbuya Nehanda Children's home is an organization that houses orphaned and abandoned children. It has about 60 children, 29 of which are over 12 years of age and are doing their secondary education. CASS has been supporting the home for the past 2 years and we have decided to build a long-term relationship with the home whereby we get to monitor the growth of the children until such a point in time that they can weaned off and create capacity for more needy children.

DK: Can you tell us more about the event and what sort of activities will be involved

AC: The donation ceremony is scheduled for Saturday 31 March 2012 at Mbuya Nehanda Children's home. CASS committee members will do the painting and repairs, with the supervision of professional painters. This will be done between 1100-1400hrs while the official hand-over will be between 1400hrs-1500hrs. The ICAZ President Mr. Brian Njikizana will be the Guest of Honour.

We bought groceries and stationery amounting to \$3,200. The groceries mainly comprise of basic food stuffs such as mealie meal, cooking oil, sugar beans, flour, toiletries etc.

We are going to paint and perform general repairs of the boys' hostel which is now in a dilapidated state. Repairs include electrical repairs and some carpentry work. We intend to carry out similar repairs on all their other

dwellings.

DK: I believe income generating projects are ideal as a form of empowerment. DO you have any for the home.

AC: I totally concur with you empowerment is quintessential towards achieving a sustainable objective. Yes we do have small projects on the cards. We re-fenced their fowl run last year therefore; we are going to donated 100 chicks as well as enough feeds until the chicks are fully grown. It is intended that the birds will be sold in order to generate revenue for the home. Depending on the outcome of this initial batch, we intend to raise more funds and increase the number of birds.

Their grinding mill had been down for a very long time and we are planning on fixing it. It is intended that the grinding mill will be used for their personal use and also as an income generating project as they can also service villagers surrounding the home.

DK: Lastly, you are making a huge impact towards a worthy cause, where is the support coming from.

AC: Thank you for complimenting our efforts. Firstly our committee is very organized and united for a common cause. We believe in making a difference therefore all our efforts are focused towards one objective. Secondly, we get support from various organisations. IESBA Revises 2012 Strategy

The IESBA has agreed on a revision to its strategy and activities for 2012. Its revised strategy calls for the board to undertake the following activities in 2012:

Rotation — The IESBA will consider firm rotation and also whether the position of the Code of Ethics for Professional Accountants (the Code) on partner rotation remains appropriate, including whether the requirement to rotate off the audit engagement after serving seven years as a key audit partner and observe a two-year time-out period continues to be appropriate.

Non-assurance services — The IESBA will consider whether the Code's position on non-assurance services remains appropriate, including the use of materiality,

and, if so, whether guidance should be provided for applying the materiality test. If certain non-assurance services are permitted,

...the IESBA might also consider whether they should be subject to pre-approval by those charged with
